To the Shareholders:

Presented herewith is the Annual Report of your Company, together with the Audited Balance Sheet and Statement of Profit and Loss for the year ended March 31, 1951.

The Net Profit for the year, after deducting all charges and expenses for management and providing for Income Taxes, amounted to \$346,729.86, as against \$296,030.83 for the previous year. The Net Profit plus the refund of Excess Profits Tax amounting to \$23,403.00, enabled your Directors to authorize the payment of Dividends on Preference and Ordinary Shares, aggregating \$365,000.00, leaving Earned Surplus at \$3,113,136.60, an increase for the year of \$5,132.86.

The high rate of Excise Taxes on Tobacco Products was further increased in the April 1951 Budget. Formerly the tax on a package of twenty cigarettes was approximately 21½ cents. Under the present Budget the tax stands at slightly over 25 cents for twenty cigarettes.

Your Company is proud of its interest in its employees, and its programme of benefits covers a wide range for their welfare and security. The success of the Company is due in no small measure to their loyal and efficient service, and your Directors express their gratitude for the efforts of the entire staff.
