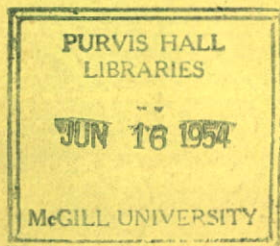

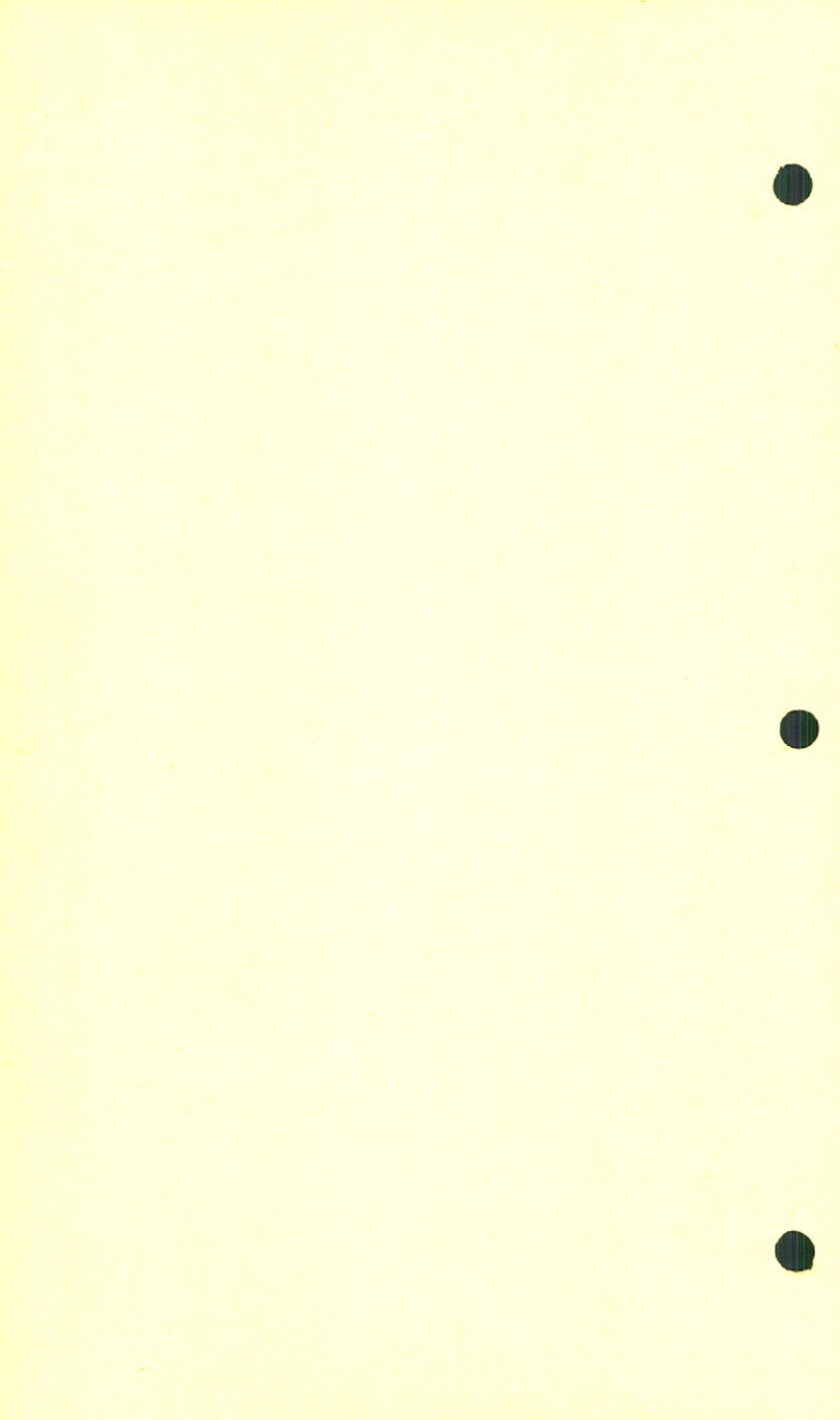

Ninety-Sixth Annual Report

MONTREAL, February 8th, 1943.

TO THE SHAREHOLDERS.

Gentlemen:

Your Directors have pleasure in presenting the ninety-sixth Annual Report of the affairs of the Bank and the result of its operations for the year ending December 31st, 1942.

The net profits for the year were \$387,782.67 and the balance brought forward from last year's Profits Account was \$149,473.46, making a total of \$537,256.13. In addition to the usual quarterly distributions to its shareholders, the Bank contributed from this amount \$13,350.00 to various charitable and philanthropic Funds — independently of the sum of \$9,950.00, interest on the Charity Donation Fund, distributed as usual — leaving a balance at the credit of undivided Profits Account of \$243,906.13 to be carried forward to next year.

Death has dealt heavily with your Board of Directors since our last Annual Meeting.

Our President, the Right Honourable Raoul Dandurand, a Director since 1906 and President of the Board since 1926, died on the 11th of March.

By his death the Bank lost a sound administrator whose good judgment and keen financial sense were of great value.

For more than half a century, our late President had filled a very prominent place in the public life of Canada. He had endeared himself to all by his unfailing kindness and courtesy and by his great personal charm.

Mr. Henry J. Trihey, whose death occurred on the 9th of December, had been a member of the Board for about twenty years and Vice-President since April of last year.

By his death the Bank was deprived of an able counsellor, held in high esteem by the Directors, an esteem and a confidence shared by Mr. Trihey's legal colleagues and by the public.

The vacancies thus created have been filled by the appointment of Honourable Léon Mercier Gouin and Mr. John T. Hackett, K.C., as Directors; the election of Mr. M. Arthur Phelan, K.C., as Vice-President and of your chairman, as President of the Board.

As usual, a frequent and thorough inspection of the books and assets of the Bank has been made during the year.

The Report of the Auditors and the Balance Sheet are herewith submitted.
