To the Shareholders:

Your Directors submit herewith the Company's Income Account and Balance Sheet as of December 31st, 1932.

The market for your products is dependent chiefly upon new construction and as this has been seriously curtailed during the year 1932, the sales of your Company show a further reduction in value which is reflected in your Profit and Loss Statement; however, your Company is receiving a fair proportion of the business available.

As in previous years, your inventories have been valued on a conservative basis; allowance for depreciation and obsolescence which has occurred during this exceptional period, have resulted in a charge to the Profit and Loss account of \$63,088.55.

Your Company's Plants have been maintained in an efficient condition and depreciation thereon amounting to \$46,853.45 has been provided during the year.

To effect further economy in operation, your capital structure was somewhat changed internally during 1932, by establishing subsidiary companies and transferring the assets to them. However, your Company owns the entire capital structure of these subsidiaries and the net position has not been affected.

Strict economies have of necessity been enforced in your Company and further reductions in salaries and rates have been put into effect.

Your organization is composed of a competent personnel and your Company has more than ample working capital at its disposal.

Meetings of your Board of Directors have been held monthly; the books of your Company have been audited regularly and the Certificate of the Auditors appears on the financial statement herewith submitted.

Your Directors wish to record their appreciation of the loyalty and efficiency of the staff throughout the organization.
