Annual Report of the Directors

YEAR ENDED JUNE 30, 1942

TO THE SHAREHOLDERS FAIRCHILD AIRCRAFT LIMITED.

Your Directors have the honour to submit their Report of the Company's operations for the twelve months ended June 30, 1942, together with the Balance Sheet and Statement of Profit and Loss and Earned Surplus.

PRODUCTION

The number of aircraft produced during the year was more than four times that of the previous twelve month period. Measured in terms of the number of aircraft produced per thousand square feet of floor space, the Company's production compares favourably with that of any other Company on this Continent.

The Company has been awarded contracts by the Department of Munitions and Supply for additional Bristol Bolingbroke Bomber Aircraft. It is anticipated that this order will be completed before the end of 1943. The Company has also been instructed to proceed with the manufacture of the Curtiss SB2C-1 Dive Bomber under license from the Curtiss Wright Corporation, Columbus, Ohio. As anticipated in last year's Report, the order for Hampden Aircraft component parts received from Canadian Associated Aircraft Limited was completed in January 1942, and the manufacturing space and personnel employed on this work were immediately made available for the production of Bolingbroke aircraft.

PLANT EXTENSION

Further additions to Plant were completed during the year and an extension is now under construction in order to provide the additional space required for the manufacture of Curtiss SB2C-1 Bomber Aircraft. When this extension is completed the Company will have available a total of over 600,000 square feet of manufacturing space compared with 38,000 square feet in 1937. These extensions and other facilities which were provided by the Department of Munitions and Supply are not included in the Company's assets.

PERSONNEL

From the beginning of the fiscal year July 1, 1941, to June 30, 1942, the Company's personnel increased more than 40%. The number of women employed increased 110%.

Payrolls for the year aggregated \$8,468,000.00.

FINANCIAL

The Profit and Loss Account for the year ended June 30, 1942, shows an Operating Profit of \$754,845.71 before provision for Depreciation of Fixed Assets.

After making this provision, the Net Profit for the twelve months was \$580,685.81 before Income and Excess Profits Taxes amounting to \$482,145.02 against a Net Profit of \$66,525.24 for the previous year. The balance of \$98,540.79 was applied against the Deficit Account, resulting in an Earned Surplus of \$67,705.17. The Company's property has been well maintained.

Your Directors desire to acknowledge the loyalty and energy displayed throughout the year by all employees of the Company.
