I have just received a telephone message from Mrs. Macdurray saying that Mr. Ross is going to telephone from Ottawa in the morning. The reason that the Annex has not been opened is that we have been waiting for certain minor things to be done, principally by M.D.4. I telephoned Col. McGibbon, the D.M.O., on Friday, and he promised to find out why such things had not been done. The list of things that are not completed that I will give below is not complete as Miss Flanagan and Dr. Robb are away. However, I drew up the following yesterday morning, not knowing that you were going to call, after discussion with Mr. Fetherstonhaugh:

- 1. Platforms and partial covering for the roof, to allow patients out of doors.
- 2. Screening of the passage between the Institute and the ward.
- 3. Completion of screening on the verandah downstairs.
- 4. Sterilizers which have not arrived.
- 5. Wall lights which have not arrived for the wards.
- 6. Gas plates, toasters, and kitchen sink, the latter has been ordered by McGill but has not yet been delivered.

The special beds provided have casters which are too small. We have requested larger casters as these do not allow the nurses to push the patients in the beds. We have made this request but whether or not it is going forward, I do not know.

I should think we will be able to open the Annex in August, but I think we should know on what basis military patients are to be handled. I have had no further information regarding this since you took the matter up with Mr. Ross.
