

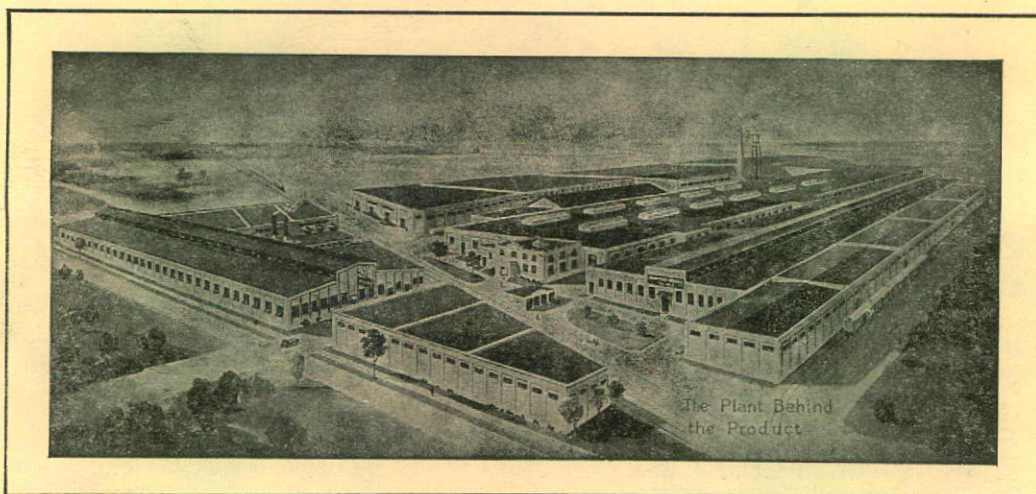

TO THE SHAREHOLDERS:

Your Directors submit herewith the Annual Report of the Company for the year ended August 31, 1942.

The operations for the year show a profit of \$204,867.93 after providing for Depreciation and Inventory Reserve and Dominion Taxes. Regular quarterly dividends, amounting for the year to \$46,449.00, were paid on First Preference Shares, and 199 First Preference Shares were redeemed and cancelled.

With crops throughout Canada well above the average, and our export business fully maintained, the volume of sales, and the results of the season's business may be considered as satisfactory.

Your Directors desire to express their sense of appreciation of the faithful and efficient services rendered under present difficult war conditions, by all its executive officers, heads of departments and employees in all branches of the Company's work.
