TO THE SHAREHOLDERS:

GENTLEMEN:-

Your Directors submit herewith their Annual Report and Statement of Accounts for the year ending December 31st, 1926.

It will be noted from the Statement that the year's operations resulted in a net profit of \$24,362.71, which has been carried to the surplus account, making a total surplus of \$62,346.91.

At the last Annual Meeting, your Directors reported that negotiations had been entered into with the Canadian and Newfoundland Governments, with a view to obtaining a revision of subsidy for the operation and maintenance of stations owned by these Governments. Your Directors are pleased to report that arrangements have been concluded on a satisfactory basis.

The Manufacturing and sale of radio sets and equipment continues to be an important branch of your Company's business, and is regarded by your Directors as a valuable adjunct to its principal operations.

Your Directors are pleased to report that the new Beam Stations erected at Drummondville and Yamachiche for communication with similar stations erected in England for the British Post Office were opened for public communication on October 25th, 1926, thus establishing the first high speed radio communication system in the world. Since the circuit from Canada to England has been in operation, other direct high speed Beam services have been established between England, South Africa, India and Australia. The opening of a direct Beam service between Canada and Australia may be looked for at an early date. This will complete the entire linking up of the British Empire by Beam Radio.

The Company's High Power station at Glace Bay, previously used for communication with England, was closed down at the opening of the Beam service, and the cost of the necessary transfer of operations has been charged against the Profit and Loss accounts for the period under review.

The Company's marine service continues to be profitable. Whilst this branch of your Company's business has shown considerable expansion, it is limited by the volume of shipping and number of vessels under Canadian registry,

Your Directors have to report the resignations from the Board of Mr. Henry W. Allen, and Mr. W. H. Peak, O.B.E. Mr. F. Perry, and Mr. Gordon W. MacDougall, K.C., have been elected to the Board to fill these vacancies.
