#### TO THE SHAREHOLDERS:

#### GENTLEMEN:-

The Balance Sheet at 31st December, 1924, is submitted herewith. Effect has been given to the reduction of the capital stock of the Company in accordance with By-law No. XXXI adopted at the Special General Meeting of Shareholders held on the 18th December 1924.

The result of the year's operations is a loss of \$42,510.70 which, as shown by the Statement, has been liquidated in the general re-valuation. The past year has borne charges for loss on exchange, and interest on loans by Marconi's Wireless Telegraph Company, Limited, London, England, in excess of the amount of loss stated. The indebtedness to the English Company has since been liquidated by the issue of capital stock at par.

Good progress has been made with the erection of the new Beam Stations at Drummondville and Yamachiche which are now ready for installation of the electrical equipment. An agreement has been entered into with Marconi's Wireless Telegraph Company, Limited [the constructors of the stations], under which payment for the stations will be effected by the issue to the English Company of capital stock in this Company at par.

The Company's Traffic Manager is now in England and is being joined in a few days by the Managing Director, to participate in a Conference on Wireless Telegraphy and to arrange with the English Company for the operation of the Beam Stations to the best advantage, and the extension of the Company's traffic connections.

Your Directors have to report the resignations from the Board of Mr. C. G. Greenshields, K.C., and Mr. G. M. Bosworth.

Dr. Milton L. Hersey has been elected President of the Company in succession to Mr. Greenshields, Mr. H. M. Short, the General Manager of the Company has been elected to the Board and appointed Managing Director and Mr. W. H. Peak, O.B.E., has been elected a Director.

The Bill promoted by the Company to ratify and confirm the re-organization of its capital, to extend its powers to include Wireless Telephony, and to change its name to Canadian Marconi Company received the Royal assent on 12th June 1925.
