DECEMBER 31st, 1955

To The Shareholders:

The Thirty-first Annual Report of your Directors with Balance Sheet as at 31st December 1955, and Profit and Loss Account for the fiscal period ended that date are submitted herewith for your approval.

Net profits for the fiscal period after providing for all operating costs and full depreciation and after Federal and Provincial Income Taxes amounted to \$228,793.14, approximately \$.71 per share, this compared with an earning of \$.97 per share for the 1954 fiscal period. Dividends paid during the fiscal period amounted to \$161,658.00 equivalent to \$.50 per share on the outstanding 323,316 No Par Value shares.


On the 1st February 1955, your Corporation redeemed \$50,000.00 of 4% Sinking Fund Bonds due on that date.

The tragic death in June 1955 of Mr. George Ganetakos, President and founder of your company was a great loss, not only to your Company but the Motion Picture Industry at large, he being one of the Pioneers of the Industry in Canada.

It is with pleasure that we announce the election of Mr. John G. Ganetakos as President and the appointment of Mr. Wm. G. Lester as Managing-Director of your Company.

May we at this time express the appreciation of your Directors for the loyalty and co-operation of the executive and employees and acknowledge to our patrons that we are very grateful for their continued support. To all of these we extend our sincere thanks.
