PROCEEDINGS OF THE

FORTY-EIGHTH ANNUAL GENERAL MEETING

WEDNESDAY, 13TH JANUARY, 1904

The Annual General Meeting of the Stockholders of The Bank of Toronto (being the forty-eighth since the commencement of business) was held, in pursuance of the terms of the Charter, at the Banking House of the Institution in Toronto, on Wednesday, 13th January, 1904.

In the absence of the President, George Gooderham, Esq., the Vice-President, William H. Beatty, Esq., was called to the Chair, and Mr. Coulson was requested to act as Secretary.

Moved by THOMAS R. WOOD, Esq., seconded by ELLIOTT W. LANGLEY, Esq., and

Resolved—That the Scrutineers of the election of Directors at this meeting be Messrs. Edward M. Chadwick and Charles H. Gooderham, and that they report to the General Manager the result of the ballot.

The past year has been one of increased activity, the trade of the country has continued to expand, and the resources of the Bank have been very fully employed.

Of the new stock heretofore authorized your Directors allotted amongst the Stockholders of the Bank 5,000 shares, representing \$500,000 Capital at a premium of 100 per cent., in the proportion of one share of new stock to every five shares of old stock as of record on 30th April last, and 4,780 shares thereof have been subscribed on which the payments of Capital have aggregated \$454,430.

The average amount of paid-up Capital throughout the year has been \$2,678,090.

Since the last Annual Meeting branches of the Bank have been opened at Board of Trade Building Montreal, Guy Street Montreal, and Maison-neuve, in the Province of Quebec; Cardinal, Coldwater, Dorchester, Omamee, and Corner Queen Street and Spadina Avenue, Toronto, in the Province of Ontario.
